- LCSW, LPCC, MFT, or Psychologist license.
- Must have 2 years post license experience if providing supervision.
- Clinical experience working with children, adolescents, and their families.
- Knowledge of the Jewish community (preferred).
- Insurance provider (preferred).
- Experience working in diverse communities and ability to bridge cultures.
- Committed to culturally informed practice and a multicultural learning environment.
- Ability to work independently and part of a team.
- Ability to maintain strict confidentiality.
- Patience, compassion, flexibility.

- Must be available to work one evening per week.
